## Site Guidelines

#### **Onsite Access/Contact Information**

- Emergency contact phone number will be through the Ava District Ranger's office of the USFS at 417-683-4428 ext 110. This number will only be available during the dates of the actual project. This is for <u>EMERGENCY</u> USE ONLY.
- Mailing address for the event is Johnny Arrowmen, Arrowcorp5 project, c/o US Forest Service, Ava Ranger District, PO Box 188, Ava, MO 65608.
- Vehicles will be parked in dead storage. You will not be able to drive the vehicle during the week within camp or to leave camp
- There will be no unauthorized visitors to the site. All authorized visitors and media must be escorted.
- No internet access will be available to check emails.
- Cell phone service is very limited in Southwest Missouri. It is likely that you will not have service once you enter the area of the National Forest. Please don't plan on having cell service to contact your family.
- Once a participant arrives at the site, they should plan to be there the entire time. In the event of an emergency and you find that you must leave camp, you must checkout at the administration tent. Your work section chief must come to the tent with you at that time you checkout. Upon return, you must report back to the administration area.

### **Things NOT to Bring**

- ATV or Gator
- Pets
- Firearms
- Chainsaws
- Lighters or Matches
- Tobacco, alcohol, drugs
- Propane or liquid fuels
- Campers or RV's
- Fireworks
- Sandals
- Valuables
- Electronic devices (ie Ipod, MP3, Gameboy, Nintendo DS...)
- All tools necessary to complete the tasks will be provided. There is no need to bring shovels, rakes, saws, or other equipment.

#### **Personal Safety**

- The buddy system will be used throughout the entire week
- There should be no open toe shoes. All participants should plan to wear socks at all times.
- Appropriate clothing for base camp activities may include shorts, t-shirts and tennis shoes. Again, no open toed shoes are allowed during the entire week.
- No food in tents
- Each person will be responsible for their own prescription medications. A refrigerator will be available in the medical area for those medications that require refrigeration. Space will be available in the medical tent to store other medications if necessary.
- All tools necessary to complete the tasks will be provided. There is no need to bring shovels, rakes, saws, or other equipment.
- All required Personal Protective Equipment must be worn whenever a participant leaves the base camp to work. If a person lacks the appropriate personal protective equipment, they will be required to purchase the appropriate pieces. This will be checked upon arrival to the site and daily. A list of required personal protective equipment is available on the Mark Twain website. Please pay special attention to the 8" leather boot requirement.

#### Curfew and lights out will be at 9:30pm.

- It is expected that all participants will observe this curfew as the physical demands of the project will dictate that each person must be at their best both physically and mentally. A curfew violation may prevent you from participating in activities.
- Tour permits are required for Council Contingents
- Each person will have 60 square feet for their tent. Two people may combine and tent together with a total of 120 square feet
- There will be no electricity for personal use
